We hereby propose to furnish all materials as well as equipment required to perform all labor necessary to complete the following work,

### JOB DESCRIPTION:

- One time application of **Ten (10) totes (275 gallons each)** of peroxide based algaecide to treat up to 315 combined surface acres at Coors Light Cove, Elm Beach, Launch Point, West Marina, South Shoreline, Davis Beach, Nano Beach, Whiskers Beach, and East Shoreline.
- One time shoreline removal of filamentous algae, dead fish, and debris along Coors Light Cove, Whiskers, Dave's, Nano, and Elm Grove Beaches' shoreline. Details are as follows:

### Scope of Work –

1. Crew will mobilize to the worksite and will have unimpeded access to the lake areas outlined below between the hours of 6am and 12pm.
2. Crew will utilize application equipment including boats and spray pumps to chemically treat algae, approximately 315 surface acres 2 to 4 feet deep, as follows
  - West Marina and South Shore- **3 Totes -130 Acres**
  - Launch Point - **2 Totes - 50 Acres**
  - Restaurant, Whiskers, Daves, Nano, and Elm Beaches - **2 Totes - 55 Acres**
  - Coors Light Cove and East Shoreline - **3 Totes - 80 Acres**
3. Crew will utilize mechanical equipment and hand tools to physically remove algae, dead fish, and other debris from the beaches' shorelines named in the JOB DESCRIPTION above.
4. Trash will be placed into dumpsters by ALVS and disposal will be performed by staff from The City of Lake Elsinore.
5. Crew leader will submit before and after pictures to The City of Elsinore upon completion.
6. Crews will demobilize from the worksite, removing all equipment and trash.

**Note: Treatment recommendations are based on manufacturer's recommendation. ALVS does not guarantee the length of time the treated area will remain free from algae. ALVS does not guarantee removal of all algae and debris in the area, but will make its best effort to remove as much as possible within the allotted time frame. Customer understands that additional treatments are necessary in order to maintain algae levels at a reasonable level.**



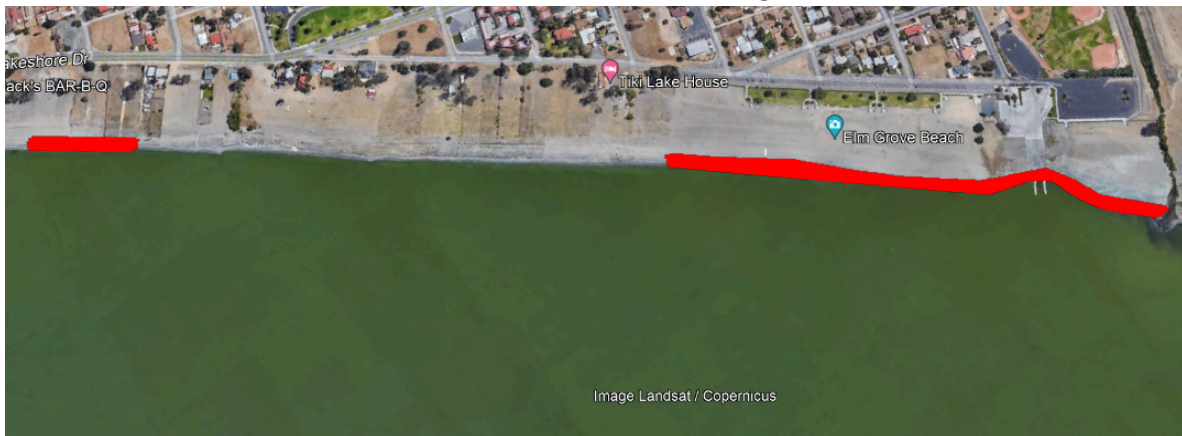
