

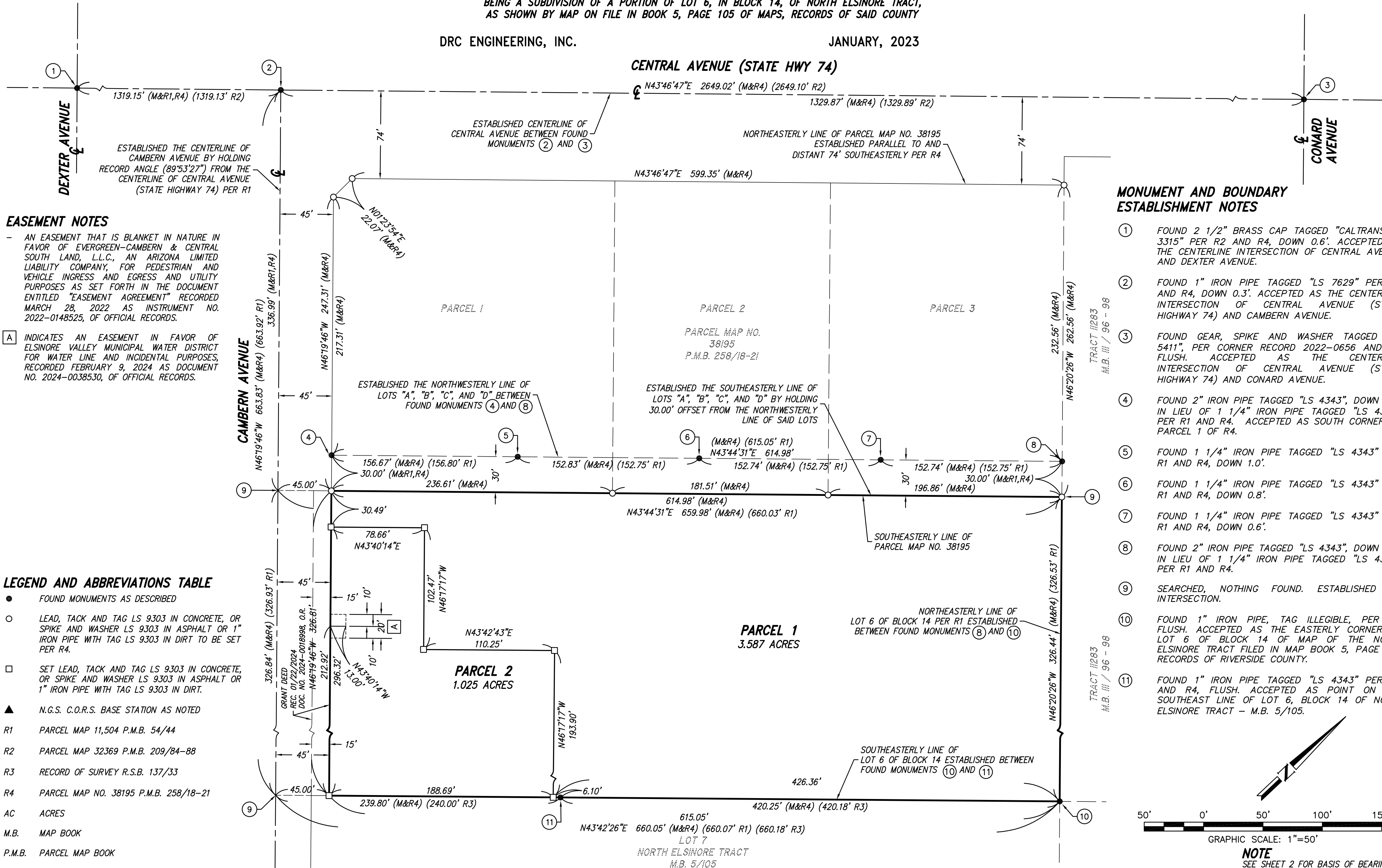

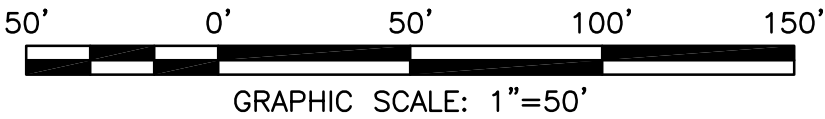

- ② FOUND 1" IRON PIPE TAGGED "LS 7629" PER R2 AND R4, DOWN 0.3'. ACCEPTED AS THE CENTERLINE INTERSECTION OF CENTRAL AVENUE (STATE HIGHWAY 74) AND CAMBERN AVENUE.
- ③ FOUND GEAR, SPIKE AND WASHER TAGGED "LS 5411", PER CORNER RECORD 2022-0656 AND R4, FLUSH. ACCEPTED AS THE CENTERLINE INTERSECTION OF CENTRAL AVENUE (STATE HIGHWAY 74) AND CONARD AVENUE.
