

**AMENDMENT NO. 1  
TO AGREEMENT FOR CONTRACTOR SERVICES**

**Top Service Plumbing Co. Inc.**

***Sewer Lift Station Pump Replacement at Summerly Park***

This Amendment No. 4 to Agreement for Contractor Services is made and entered into as of 6/11/2024, by and between the City of Lake Elsinore, a municipal corporation ("City"), and Top Service Plumbing Co. Inc., a Corporation ("Contractor").

**RECITALS**

A. The City and Contractor have entered into that certain Agreement for Contractor Services dated as of 11/14/2023, (the "Original Agreement"). Except as otherwise defined herein, all capitalized terms used herein shall have the meanings set forth for such terms in the Original Agreement.

B. The Original Agreement provided for compensation to Contractor in an amount of Twenty Thousand dollars and zero cents (\$20,000.00).

C. The parties now desire to expand the scope of services and increase compensation by an additional amount of \$32,780.97 for a not to exceed compensation amount of \$52,780.97 per fiscal year.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth herein, City and Contractor agree as follows:

1. Section 1, Scope of Services, of the Original Agreement is hereby amended to add the following:

Contractor shall also perform the services and related work described in Contractor's Proposal (Exhibit A-1), which is attached to Amendment No. 1.

2. Section 3, Compensation, of the Original Agreement is hereby amended to add the following:

Compensation to be paid to Contractor under Amendment No. 1 shall be in accordance with the fees set forth in Contractor's Proposal (Exhibit A-1), which is attached hereto and incorporated herein by reference. In no event shall Contractor's annual compensation under The Original Agreement as amended exceed Fifty-Two Thousand Seven Hundred Eighty and Ninety-Seven Cents (\$52,780.97) without additional written authorization from the City Council.

3. Except for the changes specifically set forth herein, all other terms and conditions of the Original Agreement shall remain in full force and effect.
