**First Extension of Time Request (EOT-2024-05) for Bamiyan Marketplace:** The proposed extension of time is a request by Ahmed Zaki, Zairey, Inc., to extend the life of the approved Tentative Tract Map (TTM) 37578 for an additional six (6) years to August 9, 2030 and extend the life of the approved Commercial Design Review (CDR) No. 2019-05, Conditional Use Permit (CUP) No. 2019-03, and Uniform Sign Program No. 2019-01 for an additional two (2) years to August 9, 2026. TTM 37578 is a subdivision of a 12.6-acre site into seven parcels ranging in size from 0.25 acres to 4.13 acres. CDR No. 2019-05 and CUP 2019-03 is to construct and establish the Bamiyan Marketplace with a new gas station, carwash, and drive-through restaurants. Uniform Sign Program No. 2019-10 is to establish a unified signage theme and design for the proposed retail center. The project site is located on northwest corner of Grand Avenue and State Route (SR) 74/Ortega Highway. (APNs: 381-320-020 and 381-320-023)

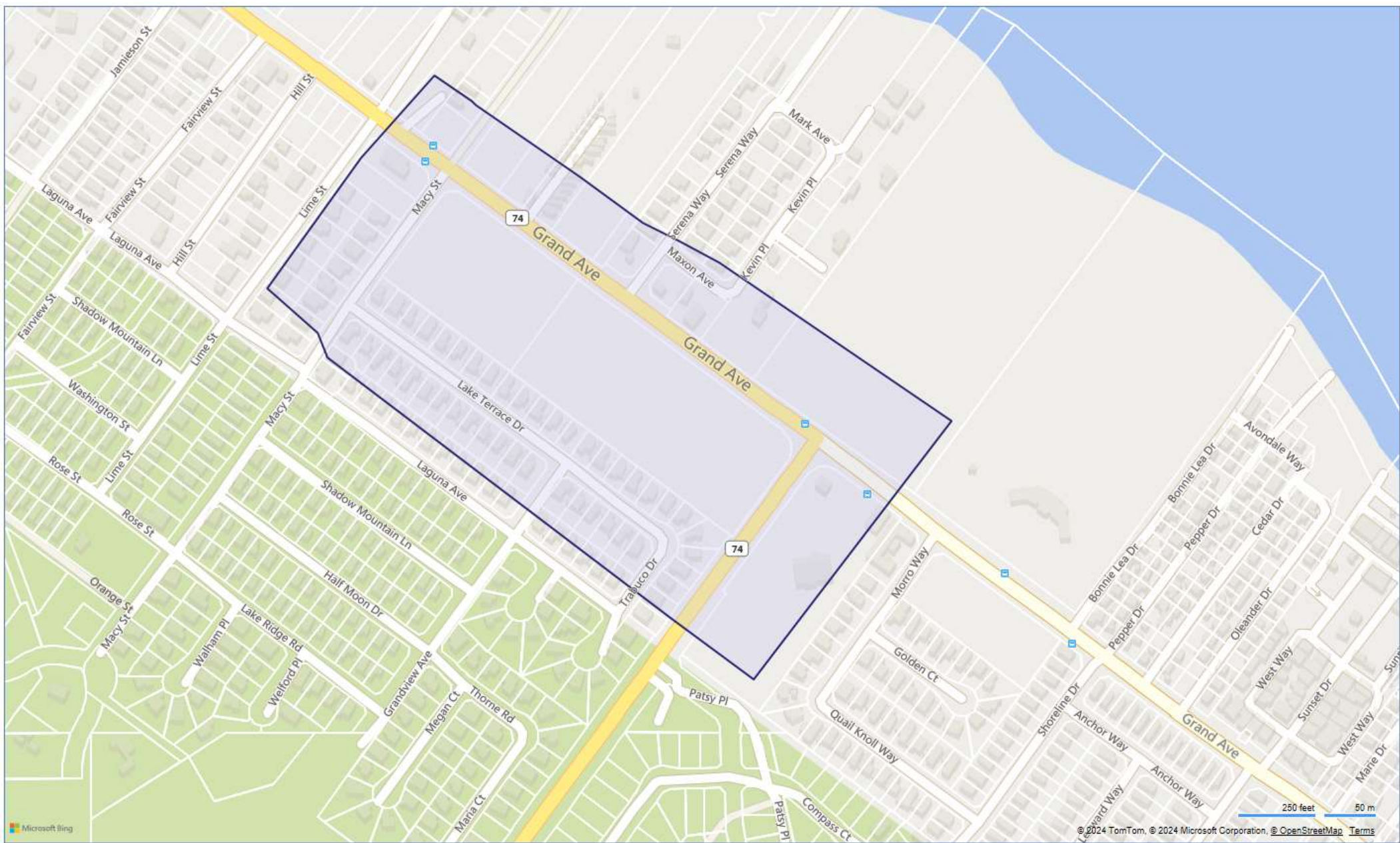
