



Thence southwesterly along said La Laguna Rancho line, South 43°57'15" West, a distance of 263.77 feet to the beginning of a non-tangent curve, concave northwesterly and having a radius of 540.00 feet, a radial bearing to said point bears South 18°47'48" East;

Thence southwesterly and westerly, along said curve, through a central angle of 20°03'01", an arc distance of 188.97 feet to said **POINT OF BEGINNING**.














