

RESOLUTION NO. 2024-___

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE ELSINORE, CALIFORNIA, CALLING FOR THE HOLDING OF AN ALL-MAIL BALLOT SPECIAL MUNICIPAL ELECTION ON TUESDAY, AUGUST 6, 2024, FOR THE ELECTION TO FILL A VACANCY OF THE CITY TREASURER AS REQUIRED BY THE PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA RELATING TO GENERAL LAW CITIES

Whereas, a vacancy in the office of City Treasurer of the City of Lake Elsinore was created when City Treasurer Allen Baldwin passed away on January 18, 2023;

Whereas, under Government Code 36512, the City Council must fill a vacancy of an elected official within 60 days from the commencement of the vacancy;

Whereas, Government Code Section 36512(b)(1) states that if the council calls a special election, the special election shall be held on the next regularly established election date (established by Elections Code Section 1000) not less than 114 days from the call of the special election;

Whereas, since none of the established election dates fall between June 6, 2024 and August 9, 2024, an all-mail ballot election would have to be conducted (Elections Code Section 1003(f)); and

Whereas, the term of office in which the vacancy occurs ends in December 2024.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKE ELSINORE DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That pursuant to the laws of the State of California relating to general law cities, there is called and ordered to be held in the City of Lake Elsinore, California, on Tuesday, August 6, 2024, a Special Municipal Election conducted by all-mail ballot for the purpose of electing one (1) City Treasurer for the term of office in which the vacancy was created which ends December 2024.

Section 2. That in all particulars not recited in this Resolution, the election shall be conducted as provided by law for the holding of municipal elections.

Section 3. That the City Clerk is authorized, instructed, and directed to coordinate with the Yolo County Clerk/Recorder/Assessor to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment, and paraphernalia that may be necessary in order to properly and lawfully conduct the election.

Section 4. That notice of the time and place of holding the election is given, and the City Clerk is authorized, instructed, and directed to give further or additional notice of the election in time, form, and manner as required by law.

Section 5. This Resolution shall take effect immediately upon its adoption.

Section 6. The City Clerk shall certify to the adoption of this Resolution and enter it into the book of original Resolutions.
