NOTICE IS HEREBY GIVEN that pursuant to California Elections Code § 10229 relating to the General Municipal Election in the City of Lake Elsinore to be held on Tuesday, November 5, 2024:

As of the close of the nomination period on August 9, 2024, there are not more candidates than offices to be elected.

The persons so nominated are:

City Council Member, District 4 - Natasha Johnson
City Council Member, District 5 - Bob Magee
City Treasurer - Edwin Castro

That California Elections Code § 10229 allows one of the following courses of action to be taken by the City Council:

1. Appoint to the office the person who has been nominated;
2. Appoint to the office any eligible elector if no one has been nominated; or
3. Hold the election if either no one or only one person has been nominated.

The City Council will hold a special meeting between Monday, August 19, 2024 and Thursday, August 22, 2024 to either make the appointments or direct the election to be held. The persons appointed shall qualify and take office and serve exactly as if elected at a municipal election for the office.

If, by the 75th day before the municipal election, no person has been appointed to the offices pursuant to (1) or (3) above, the election shall be held.

If the City Council makes an appointment pursuant to California Elections Code § 10229, the City Clerk shall not accept for filing any statement of write-in candidacy which is submitted after the appointments are made.

POR LA PRESENTE SE DA AVISO de que de conformidad con la §10229 del Código Electoral del Estado de California relacionada con la Elección Municipal General en la Ciudad de Lake Elsinore que se habrá de llevar a cabo el martes, 5 de noviembre de 2024:

Desde el cierre del período de nombramiento el 9 de agosto de 2024, no existen más candidatos que cargos a elegir.

Las personas nominadas son:

Miembro del Concejo Municipal, Distrito 4 – Natasha Johnson
Miembro del Concejo Municipal, Distrito 5 – Bob Magee
Tesorero de la Ciudad – Edwin Castro

Que la § 10229 del Código Electoral permite que el Concejo Municipal tome una de las siguientes medidas:

1. Designar para el cargo a las personas que ha sido nominadas;
2. Designar para el cargo a cualquier elector elegible si nadie ha sido nominado; o
3. Llevar a cabo la elección cuando se ha nominado a una persona por cada oficina.

El Concejo Municipal tendrá una junta especial entre el lunes 19 de agosto de 2024 y el jueves 22 de agosto de 2024 para hacer los nombramientos o para ordenar que se lleve a cabo una elección. Las personas nombradas deberán estar facultada y asumir el cargo y ejercerlo exactamente de la misma manera que si hubiera sido elegida para el cargo en una elección municipal.

Si, para el día septuagésimo quinto (75) antes de la elección municipal, no se ha nombrado a ninguna persona para los cargos de conformidad con (1) o (3) más arriba, se llevará a cabo la elección.

Si el Concejo Municipal realiza los nombramientos de conformidad con la §10229 del Código Electoral, la Secretaría Municipal no aceptará la entrega de ninguna declaración de candidatura añadida que sea presentada después de haberse realizado los nombramientos.
