

RESOLUTION NO. 2024-___

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE ELSINORE, CALIFORNIA, PROVIDING FOR THE APPOINTMENT TO THE OFFICES OF THIS CITY THAT WERE TO BE ELECTED ON TUESDAY, NOVEMBER 5, 2024

Whereas, pursuant to § 10229 of the Elections Code of the State of California, as of the close of the nomination period on Friday, August 9, 2024, there are not more candidates than offices to be elected for the City Treasurer and City Council Members for Districts 4 and 5; and that §10229 of the Elections Code allows one of the following courses of action to be taken by the City Council:

1. Appoint to the office the person who has been nominated.
2. Appoint to the office any eligible elector if no one has been nominated.
3. Hold the election if either no one or only one person has been nominated.

Whereas, a notice was published on Wednesday, August 14, 2024 in a newspaper of general circulation pursuant to law.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKE ELSINORE DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That pursuant to §10229 of the Elections Code of the State of California, the following action is being taken:

The following persons are being appointed to the offices to which they were nominated, and are considered to be the same as being elected, pursuant to §10229(a)(3) of the Elections Code:

NAME	OFFICE	TERM
Natasha Johnson	City Council Member, District 4	4 years
Bob Magee	City Council Member, District 5	4 years
Edwin Castro	City Treasurer	4 years

Section 2. The election for the above seats scheduled to be held on Tuesday, November 5, 2024 is now canceled.

Section 3. The persons appointed shall qualify and take office and serve exactly as if elected at a municipal election for the office.

Section 4. The City Clerk shall certify to the adoption of this Resolution and enter it into the book of original Resolutions.
