We propose to furnish the following materials and perform all labor necessary to complete the roof at:  
Fire Station #85 29405 Grand Ave. Lake Elsinore

Remove existing roofing and haul away.\*  
Install a class a 1/2" securrock mechanically attached.  
Install 2 layers of 15# astm paper.  
Install Quarrix Double Roman composite tile 50 year material warranty per manufacturers recommendations.  
Clean up and haul away all our debris on a daily basis.

NOTE: \*If would work is needed add \$10.00 a square foot for plywood and \$14.00 a linear foot for board sheathing.

Exclude: Two flat roofs on the rear of the building, bonds, asbestos abatement/mold remediation, framing or structural repairs, removing or lifting of any mechanical equipment, gutters/downspouts, painting, plumbing, electrical, waterproofing and insulation.

The above work to be completed in a substantial and workmanship like manner for the sum of:  
Two Hundred & Fourteen Thousand, Seven Hundred & Forty Two Dollars \$ 214,742.00

Terms: Net cash on completion. 2 -year guarantee.

- This offer valid for one week from date of estimate. Any alterations or deviations from the above specifications or building plans involving extra cost of labor or material will become an additional charge over the price quoted in this estimate.
- If this bid is accepted, work under this contract shall commence not later than \_\_\_\_\_, 2022 and will be completed by \_\_\_\_\_, 2022. The completion date shall be extended for any delays caused by inclement weather, accidents, shortages of material or labor and other delays unavoidable or beyond J J Roofing's control. J J Roofing's failure, without lawful excuse, to commence work within 20 days from date specified in this agreement shall constitute a violation of the Contractors License Law. J J Roofing shall be deemed to have substantially commenced work when it moves equipment onto the job site.
- If driveway access is required to install roofing, we assume no liability for damage to driveway caused by weight of trucks.
- When demolition is necessary, owner or tenant is responsible to take necessary precautions against interior damage caused by dust or debris.
