Recommendation

Approve and authorize the Executive Director to purchase field wall padding and associated padding repairs from Sports Field Specialties in the amount of \$158,808.25 for the Diamond Stadium field wall padding and associated padding repairs project (CIP Project #Z20003).

Background

The staff has performed research on various sport field padding options and determined the sport field padding available on the national buy board, Keystone Purchasing Network (KPN), is a great option to execute for this purchase. KPN is a cooperative purchasing program that offers premier products and excellent service at competitive prices under pre-advertised and negotiated contracts.

This purchase will provide a ready-to-install sport field padding system that will meet major league baseball requirements for the Diamond Stadium. The wall padding and associated padding repairs are needed to bring the playing field up to major league baseball standards for the 2023 season. Using the KPN considerably reduces design and fabrication time and is more economical. Purchasing the padding sections directly, on a pre-determined competitive price schedule will avoid any additional mark-ups.

Discussion

Sports Field Specialties will deliver and install the wall padding on the home run wall and perform padding repairs throughout the stadium on the railing. The major elements of this project are included below:

- BaseZone® Field Wall Pad - Size: 4'W x 4'H x 3-3/4"D, 3" High Impact Polyurethane Foam, UV Resistant Outdoor Vinyl Covering, 3/4" Moisture Resistant Composite Backing, Aluminum Z-Clip Wall Mounting System.
 - Top Stacked Pad for Outfield Wall
 - Bottom Stacked Pad for Outfield Wal
 - 4'W x 7'6"H Pads for LF Wall
 - (2) 12'H x 11" dia Foul Pole Pads
- Custom Digitally Printed Graphics - High-Resolution Logos & Lettering (4) Distance markers
