Subject: 2024 Annual Consumer Price Index Increase for Refuse Collection Services Provided by CR&R

Recommendation

Receive and file the 2024 Annual Consumer Price Index Increase for Refuse Collection Services provided by CR&R since the rate increases fall within the allowable amount per the Franchise Agreement.

Background

CR&R, Incorporated holds an exclusive franchise in the City of Lake Elsinore to collect and dispose of refuse and to collect and process recyclables in the City. The franchise contract specifies that rates be adjusted annually to reflect changes in the Consumer Price Index (CPI) and any increases in the Riverside County Landfill Fees. Pursuant to the formula established in the Franchise Agreement, increases in the landfill tipping fee are passed through on a pro-rata basis effective at the start of the first full billing period after the landfill fee is adjusted. The current monthly residential rate is \$31.55, which includes the Landfill Fee of \$3.78.

Discussion

The CR&R requested increase in service rates is based on the data supplied by the Bureau of Labor Statistics for the 12 months ending March 31, 2024, in which the Consumer Price Index (CPI) for the Los Angeles, Riverside and Orange County area increased by 2.99%.

In addition, City staff was notified that the County of Riverside Waste Management Department will not be adjusting their landfill disposal rate for Fiscal Year 2024-2025.

Due to the increased CPI adjustment factor, a monthly rate adjustment will become effective for residential and commercial accounts. The monthly residential rate will go from \$31.55 per month

to \$32.18 per month. The commercial rates for fiscal year 2024-2025 reflect the bundled services; per the guidelines from CalRecycle to prepare for the implementation of SB 1383.

The new rates are reflected in Exhibit A (Exhibit "C") and will become effective July 01, 2024.

Fiscal Impact

There is no negative fiscal impact to the City. This rate adjustment will result in a slight increase in franchise revenues for the City.

Pursuant to our current Solid Waste and Recycling Services Agreement with the City of Lake Elsinore, CR&R Incorporated (CR&R) respectfully submits the attached information which outlines our Annual Rate Adjustment request for fiscal year 2024-2025. As you are aware, our current agreement stipulates the conditions upon which our rates may be adjusted on an annual basis. Per the agreement, these rates shall be adjusted each July 1st to reflect the changes in various applicable indices.

In reviewing the data from the Bureau of Labor Statistics (BLS) for March 2023 through March 2024, the CPI has increased by 2.99%. In addition, the County of Riverside's Waste Management Department has indicated that they will not be adjusting their landfill disposal rate for fiscal year 2024-2025.

These standard adjustments would be effective July 1, 2024.

As we have stated in prior years, we greatly appreciate our long-standing relationship with the City of Lake Elsinore, as well as the opportunity that we have had to be of service to your residents and businesses.
