### **Recommendation**

Approve and authorize the Executive Director to execute a Purchase Order with Quick Crete Products in an amount not to exceed \$175,622.07 (including tax) for 2 Monument Signs and 12 Concrete Baseball Bollards at Lake Elsinore Diamond Stadium in such final form as approved by the Agency Attorney and authorize the Executive Director to execute change orders not to exceed a 10% contingency amount of \$17,562.00 for unanticipated costs.

### **Background**

The two monuments from Quick Crete Products will be installed at the intersections of Diamond Drive and Pete Lehr and Diamond Drive and Malaga. Additionally, 12 36" concrete baseball bollards will be installed along the main entrance of the Lake Elsinore Diamond Stadium.

The installation of the monuments and concrete baseball bollards will enhance the aesthetic appearance and provide a sense of identity to the intersections and the Lake Elsinore Diamond Stadium entrance. The monuments will serve as landmarks and contribute to the overall beautification of the area.

### **Discussion**

The monuments will serve as visually appealing focal points at the intersections, drawing attention and creating a sense of identity. They will be designed to reflect the local culture and history, adding uniqueness and charm to the area.

**Fiscal Impact**

Funds with ROPS funding are available in the Fiscal Year 23-24 budget.

PLAN VIEW




